ORDINANCE NO. 2019-003

AN ORDINANCE PROHIBITING LOITERING IN PUBLIC PLACES, AND PLACES OPEN TO THE GENERAL PUBLIC IN THE MUNICIPALITY OF ALEGRIA

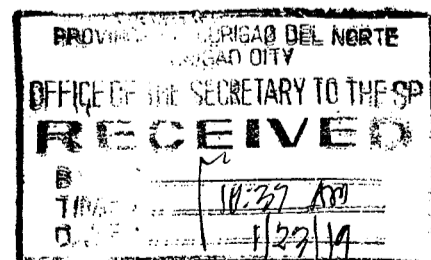

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF ALEGRIA, IN SESSION ASSEMBLED, THAT:

SECTION 1 . TITLE. This Ordinance shall be known and maybe cited as “**Anti-loitering Ordinance**”.

SECTION 2. DEFINITIONS. For purpose of this ordinance, certain terms or words used herein shall be defined as follows:

Loitering: Shall mean remaining idle in essentially one location and shall include the concept of spending time idly, loafing, or walking about aimlessly, and of standing or gathering upon any public place so as to hinder or impede, or tend to hinder or impeded the passage of pedestrians or vehicular traffic.

Municipal Ordinance No. 2019-003

Public Place: shall mean any street, sidewalk, alley, public building, public parking lot, and any place of business or assembly open to, or frequented by the public, and any other place which is open to the public view or to which the public has access. It includes any highway, boulevard, avenue, road, street, bridge or other thoroughfare, park, plaza, square, and/or any open space of public ownership where people are allowed access. (*Public Assembly Act of 1985*)

SECTION 3. No person shall, after being warned, loiter in a public place or place open to the general public in such a manner as to:

- (a) Create or cause to be created, a danger or a breach of peace;
- (b) Hinder or obstruct, or tend to hinder or to obstruct, the free passage of pedestrians or vehicular traffic;
- (c) Obstruct, molest, or interfere with a person in such a manner as to cause them fear for their safety;
- (d) Disturb the comfort and repose of a person acting lawfully by such action as making unsolicited remarks of an offensive, disgusting, threatening or insulting or which are calculated to annoy or disturb the person to whom made or in whose hearing they are made.
- (e) To stay idle in essentially one location and shall include the concept of spending time idly, loafing, or walking about aimlessly, and of standing or gathering upon any public place so as to hinder or impede, or tend to hinder or impede the passage of pedestrians or vehicular traffic.

SECTION 4. Whenever such action or activity enumerated in Section 3 is taking place in a public place, or open place to the general public, any police officer may order the person so acting to cease and leave the premises or place.

SECTION 5. Any person who shall violate any provision of this Ordinance, after being duly warned shall be responsible for a civil infraction and subject to the following:

- 1ST - warning
- 2ND - community service (8 hours)
- 3RD - Php2,000.00 fines

SECTION 6. EFFECTIVITY. This Ordinance shall take effect after review from the Sangguniang Panlalawigan and declare the validity of the same.

Let this ordinance be forwarded to the Sangguniang Panlalawigan of Surigao del Norte for appropriate review and approval, be posted to the conspicuous places in the Municipality and to all barangay halls for the information and guidance of the general public after appropriate public hearing is done.
