AN ORDINANCE PROVIDING DISCOUNTED FARES OF NOT LESS THAN 20% OF THE AUTHORIZED FARE ON PUBLIC UTILITY TRANSPORT VEHICLES TO DISABLED PERSONS WITHIN THE JURISDICTION OF ALEGRIA, SURIGAO DEL NORTE

WHEREAS, it is a declared policy of the state to give full support to the improvement of the total well-being of disabled and their integration into the mainstream of society.

WHEREAS, towards this end, the rehabilitation of disabled persons shall be concern of the Local Government Unit of the Municipality of Alegria in order to foster their capacity to attain meaningful productive and satisfying life.

WHEREAS, Section 27, Chapter 6 of Republic Act No. 7277, otherwise known as the Magna Carta for Disabled Persons" mandates to develop a program of assistance for the marginalized disabled persons to gain access in the use of public transportation facilities.

WHEREAS, the Local Government Unit of Alegria to contribute positively to the intent of RA No.7277 sees fit the enactment of an ordinance that will respond to the mandate of developing a program to assist persons with disabilities.

WHEREFORE: Be it Ordained by the Sangguniang Bayan of Alegria, Surigao del Norte, in session assembled, that:

SECTION 1. Only persons with disabilities who are residents of the Municipality of Alegria and duly registered and member of the Person with Disabilities Association are qualified to claim fare discount.

SECTION 2. All public utility transport vehicle drivers playing within the territorial boundaries of Alegria, Surigao del Norte are mandated to give discounted fares of not less than 20% of the authorized fares for all with active PWD Identification Card (ID) holder duly signed by the Municipal Mayor.

However, if the disabled person is a Senior Citizen or the same time student he/she is entitled to one (1) discount only.

SECTION 3. Disabled Persons rides on public utility transport vehicles must be given seats that can be accessible to them. Accessible seats that are already occupied must be vacated and given to the disabled person concerned.

SECTION 4. For purposes of this Ordinance, disabled persons are those suffering from restriction of different abilities as a result of mental, physical or sensory impairment to perform an activity in the manner or within the range considered normal for human being.

SECTION 5. PENAL PROVISION. Failure or refusal of the driver to comply with Section 2 and Section 3 hereof shall, upon conviction, be penalized with a fine;

SECTION 6. EFFECTIVITY. This Ordinance takes effect immediately upon approval.
