



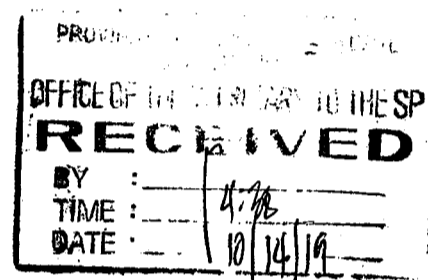

**MUNICIPAL ORDINANCE NO. 09
SERIES OF 2019**

AN ORDINANCE IMPOSING CURFEW ON MINORS BELOW EIGHTEEN (18) YEARS OF AGE FROM 10:00 O’CLOCK IN THE EVENING TO 4:00 O’CLOCK FOLLOWING MORNING, AND PROVIDING MEASURES AND ITS STRICT OBSERVANCE AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

Be is ordained by the Sangguniang Bayan in session assembled, that:

SECTION 1 – Title. - This ordinance shall be known as **CURFEW ORDINANCE FOR MINORS of 2019.**

SECTION 2 – Prohibition. – Minors under eighteen (18) years of age are prohibited to loiter, idle, wander, stroll or play upon the public streets, highways, roads, alley, parks, playgrounds, public places, public buildings, vacant lots or unsupervised places in the Municipality of Alegria between the hours of 10:00 o’clock in the evening to four o’clock the following morning.

SECTION 3 – Exceptions. – The provision of Section 2 hereof shall not apply in the following instances:

- a. When the minor is accompanied by the minor’s parent, guardian or other adult person or persons in authority having the care and custody of the minor;
- b. Where the minor is on emergency errand;
- c. Where the minor is traveling to, directly coming from work, school, church or civic event;
- d. When the minor is on a sidewalk in front of his home

SECTION 4 – Violation. – Minors found violating this Ordinance shall be brought to Alegria Police Station for verification and record purposes, and, within a reasonable time, turned over to the Curfew Center of the MSWD and eventually to the parents or guardian of the minor;

SECTION 5. Curfew Center. A Curfew Center shall be established by the Municipal Government in coordination with, and under the supervision of, the Municipal Social Welfare and Development Office, which shall be composed of social service providers and volunteers, providing intervention for juveniles and their families.

The Municipal Social Welfare and Development Office shall promulgate rules to implement the provisions of this Ordinance by creating specific procedures for repeat offenders, and provide recreational, educational, religious anti-drug and anti-gang programs.

SECTION 6. PNP. – The local PNP shall enforce this Ordinance by conducting roving patrols during curfew hours and bring minors found violating this Ordinance to the Alegria Police Station for verification and record purposes, after which the minors shall be turned over to the Curfew Center of the MSWD.

If during curfew hours the minor is found about to commit, is committing, or has committed an offense punishable under our penal laws, the said minor shall be dealt in accordance with RA 9344 and other laws.

SECTION 7. Barangay. – The Barangay officials and tanods shall assist in the implementation of this Ordinance in their respective Barangay by monitoring and reporting violators to the local PNP.


SECTION 8. Parents or Guardians. – It shall be the responsibility of the parents, grandparents, guardians, or other adult person, having the care and custody of a minor to strictly implement the observance and compliance of this Ordinance on their minor children;

SECTION 9. Schools. – Heads of schools, administrators, principals and teachers, shall inculcate the strict observance of the curfew hours as provided in this Ordinance on their students and pupils who are minors.

SECTION 10. Temporary and automatic suspension of curfew Hours. –

- a. The Sangguniang Bayan may, through a resolution, **temporarily** suspend the implementation of curfew hours on special events or as exigencies may require it, and on the following instances;
 1. Barangay Annual Fiesta, Adlaw nan Barangay of the barangay concerned;
 2. Other Festivities
- b. The implementation of the curfew hours is **automatically** suspended on the following instances:
 1. Valentines Day
 2. Holy Thursday
 3. Good Friday
 4. Black Saturday
 5. Easter Sunday
 6. Municipal/Town Fiesta
 7. Adlaw nan Alegria
 8. November 1 & 2
 9. December 24 and 25
 10. December 31
 11. January 1

SECTION 11. Funding. – An initial amount of One Hundred Thousand Pesos (Php100,000.0) shall be appropriated out of the Municipal funds to defray the expenses of the curfew center and the same amount shall be included in the annual budget of the MSWD.

SECTION 12. Repealing Clause. – All ordinances, rules and regulations, or part thereof, in conflict with, or inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 13. Effectivity. This ordinance shall take effect upon approval of the Sangguniang Panlalawigan of Surigao del Norte.
