

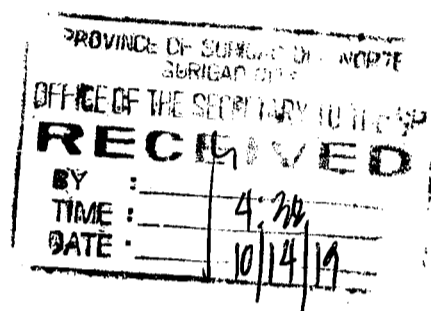

**MUNICIPAL ORDINANCE NO. 13**  
Series of 2019

Introduced by: Hon. Reuel O. Jalasan

**AN ORDINANCE CLEARING THE ROADS, SIDEWALKS, ALLEYS, STREETS, AVENUES, BRIDGES, PARKS AND OTHER PUBLIC PLACES IN THE MUNICIPALITY OF ALEGRIA OF ALL ILLEGAL STRUCTURES AND OBSTRUCTIONS**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN SESSION ASSEMBLED, THAT:**

SECTION 1 - The Barangay Officials within their respective territorial jurisdiction, jointly assisted by the Municipal Engineering Office and Mayor's Task Force shall clear from any obstruction and illegal structures all sidewalks, streets, alleys, avenues, bridges, parks and other public places within the Municipality of Alegria as provided in DILM MC 2019-121.

SECTION 2. The use of public roads, streets, sidewalks, avenues, alleys, bridges, pedestrian lanes, parks and other public places in the Municipality of Alegria for commercial and personal purposes shall be prohibited. Such prohibitions include but not limited to the following:

1. Construction or extension of commercial, residential, and similar structures within the public roads, streets, sidewalks, avenues, alleys, bridges, pedestrian lanes, parks, and other public places;
2. Drying copra, palay and similar products;
3. Dumping garbage;
4. Setting up of basketball goal or court or its similar structures;
5. Storing of construction materials;

6. Storing of softdrinks and similar commodities;
7. Storing of junks and other recyclable materials;
8. Vulcanizing shops and tire signages;
9. Installation of picket fence for livestock or the like;
10. Establishment of markers, sign boards, billboards, and the like within the authorized easement;
11. Use of sidewalk or road shouldering for all plant seedlings for sale;
12. Conduct of religious or social activities;
13. Use of sidewalks, roads, pedestrian lanes as parking or garage area;
14. Activities, n.e.c

SECTION 3. All items, goods, structures that cause obstruction shall be confiscated, and demolished shall be confiscated, and demolished without prior notice and be treated as common garbage and shall be disposed as such. The municipal government and its task force implementing this ordinance shall not be held liable from any damages arising from implementation and enforcement of the same.

SECTION 4. The Municipal Government of Alegria reserves the right at its option to dispose all illegal goods, materials and structures that are confiscated and demolished at the dumpsite or in any manner most safe and convenient.


This Ordinance does not mean to include road widening.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect immediately.
