# **MUNICIPAL ORDINANCE NO. 2020-007**

AN ORDINANCE TO COMBAT THE SPREAD OF CORONA VIRUS DISEASE (COVID-19), IMPLEMENTING THE PRESIDENTIAL PROCLAMATION 922 AND 929, AND REPUBLIC ACT 11332, OTHERWISE KNOWN AS THE "LAW ON REPORTING COMMUNICABLE DISEASES" & IMPOSING PENALTIES TO THE VIOLATORS

WHEREAS, Presidential Proclamation 922 placed the whole Philippines under the State of Public Health Emergency due to Corona Virus Disease 19 (Covid 19); and eventually declared the State of Calamity by Proclamation No. 929 due to the increasing case of Covid-19 despite government interventions;

WHEREAS, provided in the said proclamations that all government agencies and LGUs are enjoined to undertake the necessary and appropriate disaster response and timely action to curb the proliferation of Covid-19 cases;

WHEREAS, the Municipality of Alegria is also placed under "State of Health Emergency" per SB Resolution No. 2020-044 due to the increasing case of Persons Under Monitoring, presence of PUI and as a Point of entry in the Province of Surigao del Norte;

WHEREAS, it is but proper for the people of the municipality of Alegria to follow stricter rules as given by proper authorities for the protection and prevention of everybody as the case of contamination is rising and spreading rapidly;

NOW THEREFORE: be it enacted by the Sangguniang Bayan in session that:

**SECTION I** – Title – This Ordinance shall be known as Combat Covid-19 Ordinance in the Municipality of Alegria.

## SECTION II – DEFINITION OF TERMS.

- a) Quarantine—a period of not less than fourteen (14) days of isolation in which people that arrived from elsewhere especially from those known contracted or exposed with Corona Virus (Covid 19). At the height of this pandemic, the entire Philippines is placed under mandatory home quarantine which put everybody to stay at home subject to DOH Protocols.
- b) Persons Under Monitoring (PUM) person or persons with travel history from places with cases of Covid 19 who are asymptomatic but still need to be recorded at the Barangay for proper monitoring by the authorities;
- c) Persons Under Investigation (PUI) person or persons with or without travel history from places with known case of Covid 19 who showed any of the symptoms per risk assessment by the DOH Personnel.
- d) Hoarding is the undue accumulation by a person or combination of persons of any basic commodity beyond his or their normal inventory levels or the unreasonable limitation or refusal to dispose of, sell or distribute stocks of any basic necessity of prime commodity to the general public or the unjustified taking out of any basic necessity or prime commodity from the channels of reproduction, trade, commerce and industry.
- e) Profiteering is the sale or offering for sale of any basic necessity or prime commodity at a price gross in excess of its true worth.
- f) Isolation Facility refers to a separate and designated facility within a specific for PUI's who need isolation subject to DOH Protocol on Covid-19 Pandemic.

SECTION III – Regulatory Provisions. Following regulations shall strictly be followed:

- 3.1. Implementation of Home Quarantine. Home quarantine shall be implemented to prevent the spread of infection.
- 3.1.1 The Punong Barangays shall head the monitoring of people in the Barangay;
- 3.1.2 The purok heads, CVO, BNS, BHW shall be mobilized to check the compliance of mandatory home quarantine;
- 3.1.3 People aging 18-59 years old can be eligible to acquire quarantine pass provided such person has no pre-existing condition subject to DOH Protocol.
- 3.1.4 Persons classified under vulnerable sector like senior citizens and elderly who cannot be granted pass, the barangay shall take the errand for the said persons like buying foods and medicines, and similar commodities.
- 3.1.4 Quarantine Pass classified:
  - 1. Inter-Barangay Pass from Barangay (1 per family) to buy food & medicines;
  - 2. Travel Pass a). Vehicle & Driver Pass requirement: Driver's License, Barangay Pass, OR/CR to be issued by the mayor;
    - b) Passenger Pass Requirement. Brgy. Pass to be issued by the mayor;

Provided, that such "quarantine pass" shall be issued for FREE.

Provided further, that an "all access pass" maybe issued to local government functionaries involved in the implementation of policies, rules and regulation against the spread of COvid-19; subject to DOH Protocols.

To ensure people from possible transmission of Covid-19; the following conditions shall be given a "quarantine pass" subject to DOH guidelines and curfew ordinance; provided with appropriate justifications; namely:

- a) Buy Food and other basic necessities (8:00 a.m. to 5:00 p.m. only); or store workers selling basic goods such as but not limited to groceries and other necessities.
- b) Bank or financial institution (Soemco, Cantilan Bank, ALMUCO, Money Transfers only; limited to Palawan, M. Lhuiller as available in Alegria) (8:00 a.m. to 5:00 p.m. only)
- c) Buy Medicines (at the local Pharmacy) with subject to the DOH conditions and protocols except for emergency cases;
- d) People working or making a living outside Alegria;
- e) Drivers:
- f) Farm Workers, fishermen, construction workers and home service providers

Exempted in the Home Quarantine Pass provided the concerned person does not show any symptoms subject to DOH protocols;

- a) Government Employee under skeletal force subject to appropriate order;
- b) Health Workers and other frontliners
- c) Local Government and Barangay Officials
- d) PNP, AFP, BFP& other authorized government officials and other front liners

The quarantine pass shall be a uniform format.

- 3.2 Operation of Barangay Talipapa. Barangays shall designate a place for Local Talipapa shall be operated in barangays Pongtud, San Juan, Alipao, San Pedro, Budlingin, Camp Eduard and Ferlda to prevent people from flocking to the Municipal Public Market. Implementation of "Window hours" shall be observed. Provided that every barangay shall set specific window hours subject to DOH Protocols.
- 3.3. **Mandatory Reporting**. Presence of any visitor or family member from outside the jurisdiction of Alegria shall be reported at once, may this person comes from reported or no-reported case of Covid-19 to the Barangay Health Emergency Response Team (BHERTs) subject to DOH Protocol.

Provided that any person coming in to the Municipality of Alegria particularly from places with contaminated with Covid-19 shall sign a declaration form and answer appropriate questions under oath. The Inter-agency Task Force against Covid-19 is tasked to produce such form per DOH guidelines. Any mis-declaration shall be charged for a case of perjury.







## 3.4. Transportation.

- a) Only tricycle with appropriate MTOP (unit from Alegria shall be allowed to operate unless lifted or extended. To conform with the "Social-distancing" policy, to which shall carry three (3) passengers and no back ride shall be allowed; i.e. one passenger each seat. A minimum fare of ten (10.00) shall be allowed and shall implement the usual fare soon Covid-19 pandemic is over.
- b) Cargo Vehicles loaded with basic necessities passing thru the Municipality shall be allowed to pass the checkpoints provided with appropriate travel documents, implementation of related food lane shall be observed. Provided, however, only two persons per truck shall be allowed. Provided further that the allowed persons shall wear the appropriate mask or face coverings.
- c) Policy on Social Distancing shall be observed in private vehicles and subject to DOH Protocols. Private vehicles and its passengers shall secure the necessary vehicle and passenger pass prior to its trip. Provided, that such passengers shall not go out nor leave his/her car beyond what is stated in the pass.
- d) No leisure ride on motorcycle shall be allowed except to take errand like buying essential necessities within the Municipality, Provided that, back ride shall not be allowed except for those listed in the exemptions.
- e) "Habal-Habal", "skylab" shall be allowed within the mountain barangays (Budlingin, Camp Eduard and Ferlda) limited to one passenger only and shall be advised to wear masks subject to health protocol.
- f) Public Utility Vehicle (multicabs, vans) shall be allowed Alegria to Surigao City subject to DOH Protocol and provided shall observe proper distancing; i.e. half of its capacity.
- 3.5. Curfew. Curfew hours for all residents. from 9:00 p.m. to 4:00 a.m. the following morning shall be strictly implemented. Emergency cases shall be subject to DOH guidelines and protocols. Twenty- Four (24) hour curfew to minors, senior citizens, pregnant women (except those who are issued with travel pass by the governor, mayor or barangay captain by reason of their work, and persons with pre-existing medical conditions shall be observed per Provincial EO 20-011, s. 2020;
- 3.6 **Liquor Ban**. Consumption and Selling of Liquor, Alcoholic Beverages and Distilled Products shall be temporarily prohibited until the end of Enhance Community Quarantine. Anybody found violating this provision shall be meted with a case of "Social Disturbance" which is punishable under the Revised Penal Code of the Philippines.
- 3.7 Religious and Private gatherings, group activities, sports activities and other related groupings, shall be considered cancelled and prohibited;
- 3.8. Social Distancing of 1.0 meter apart shall be strictly followed. Grocery stores, public markets and other business establishments which tender frontline services shall limit the number of customers in a certain time to observe social distancing.
- 3.9 On Hoarding and Profiteering or Overpricing of goods and other commodities. The office of the Municipal Treasurer thru the BPLO shall be designated as price watch in the LGU. The Municipality shall activate its Price Monitoring Council for this purpose. Hoarding and profiteering are punishable under RA 7581 and Republic Act 71.

- 3.10 Wearing of Mask or any face covers shall be required at all times when going outdoors, in public places, taking a public or private transportation, subject to DOH protocols.
- 3.11. Cockfighting & Illegal Gambling. Holding of any cockfights and other illegal gambling activities shall be strictly prohibited. Violation to this provision shall be subject to the provisions of PD 1602 and other relevant laws in this regard.

**SECTION 4. ON PUM's & PUI's.** Subject to DOH guidelines and Protocols, all PUM's and PUI's shall be monitored by the personnel from the Municipal Health Office and other DOH personnel to be assisted by Barangays Officials, Barangay Health Workers, , Tanod, BHERTs, BNS, and Purok Presidents concerned.

Provided that, upon completion of the prescribed quarantine requirement, the LGU thru the MSWD Office shall provide medical assistance and psychological first aid to the identified PUI or PUM which shall be administered by a competent personnel and subject to DOH protocols.

SECTION 5. On Government Employees. The LGU shall implement the "skeletal workforce" for the non-frontline services subject to CSC MC 07-2020 and other pertinent Civil Service Rules and Regulations.

SECTION 6. Reiteration of Municipal Ordinance No. 03, series of 2019, re: AN ORDINANCE PROHIBITING LOITERING IN PUBLIC PLACES, AND PLACES OPEN TO THE GENERAL PUBLIC IN THE MUNICIPALITY OF ALEGRIA. Violators shall be subject to Section 5 thereof.

SECTION 7. **ISOLATION FACILITY**. The LGU and Barangays shall identify Isolation Facility which shall house PUI's. Such facility shall pass thru the DOH guidelines on the establishment of an Isolation Facility. In case a PUI in the isolation room shows symptoms of a Covid-19 positive, proper handling by health care professionals shall be followed especially on transport to identified hospital for treatment. The MHO shall determine the qualification of patients to be confined at the isolation facility.

SECTION 8. AIDS & RELIEF GOODS. Any relief goods, aids from private entities and other government entities shall conform with the protocol set by the Inter-Agency Task Force on Covid-19 and coordinate with the MDRRMO and MSWDO.

## **SECTION 9. PENALTY CLAUSE**

In addition to those provisions punishable under the Revised Penal Code; this LGU shall impose to the violators of this Ordinance a penalty of not more than Php2,500.00 for any violation. Subsequent violations shall be meted with accordingly under the Revised Penal Code of the Philippines.

SECTION 10. Person to Enforce this Ordinance. Inter-Agency Task Force against Covid-19 headed by the Local Chief Executive, Punong Barangays, PNP, BPLK, shall be tasked to implement this Ordinance.

SECTION 11. Relevance to Children's Right. Any minors apprehended as a result of the implementation of this Ordinance, pertinent laws on the right of a child per provisions of the Municipal Children's Code shall prevail and be enforced.

SECTION 12. **SEPARABILITY CLAUSE**. If for any reason, any provision or provisions of this ordinance may be declared invalid by the reviewing authority; the remaining provisions not herein affected shall be in full force and effect.

SECTION 13. **EFFECTIVITY**. This ordinance shall take effect immediately upon approval and remains effective until the State of Calamity on Covid-19 is lifted.
