MUNICIPAL ORDINANCE NO. 2020-09

**AN ORDINANCE SETTING UP REQUIREMENTS IN THE
IMPLEMENTATION OF GENERAL CONSTRUCTION
WORKS IN THE MUNICIPALITY OF ALEGRIA, SURIGAO
DEL NORTE DURING GENERAL COMMUNITY
QUARANTINE IN RELATION TO COVID-19 PANDEMIC**

Introduced by: Hon. Arnold L. Dagcuta & Hon. Eldy S. Gabeligno

WHEREAS, pursuant to Omnibus Guidelines on the Implementation of Community Quarantine issued by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases provided that all private and public constructions are permitted to resume work;

WHEREAS, the national government and other national line agencies, private construction firms and the like have undertaken projects in Alegria with workers/workforce coming from outside the Municipality and even outside the province of Surigao del Norte;

WHEREAS, while Caraga Region is under General Community Quarantine it is believed that the LGU should not be complacent and must observe proper protocol to avoid the entry of infectious Covid-19 virus;

NOW THEREFORE: be it enacted by the Sangguniang Bayan in session, that:

SECTION 1 – Title. This Ordinance shall be known as requirements in the implementation of construction works in the Municipality of Alegria;

SECTION 2 – Declaration of Policy. It is the policy of this LGU to ensure healthy working condition of people undertaking public works as well as keep the community free from the spread of this dreadful Covid-19.

SECTION 3 – Definition of Terms. For purpose of this Ordinance, the following terms are hereby defined:

a) *Construction Work* – any infrastructure projects undertaken in the Municipality of Alegria such as but not limited to residential, commercial buildings, and the like;

b) *Contractors* – is defined as the firm, company or person undertaking a certain public or private infrastructure or any construction work or to perform a certain project;

c) *Host municipality* – means the LGU of Alegria where the project shall be implemented;

d) *Localized hiring* – means that workforce of a certain project either private or public works are hired within the host locality;

e) *Private Construction Project* – are projects undertaken by a private entity, private person, such as but not limited to residential buildings, business establishments, and the like;

f) *Public Works* - is defined as any infrastructure projects undertaken by the national government in the Municipality of Alegria; such as but not limited to roads, schools, reservoirs, irrigation canals/system, among others;

g) *Quarantine* – a state, period or place of isolation in which people that arrived from elsewhere or have been exposed to infectious or contagious diseases are placed;


h) *Workers, Construction Workers* – manual laborer employed in a physical construction of the built environment and its infrastructure.

SECTION 4. Administrative Provision.

a) Hiring of Labor force, Technical staff and its equivalent for projects implemented in the municipality shall be done locally;

b) Highly technical employees, managerial positions, chief of division or its equivalent shall undergo quarantine subject to applicable protocol prior to its work resumption;

c) All private or public projects to be undertaken in the Municipality of Alegria shall coordinate with the Office of the Mayor and present the project manpower requirement;





d) Record or list of laborer/s or workforce shall be submitted every Friday to the Office of the Mayor for appropriate monitoring. Likewise, the host barangay shall conduct a periodic inspection to the site to ensure that the provision of this Ordinance is properly implemented;

SECTION 5. AUTHORITY TO ENFORCE. The Office of the Municipal Mayor thru the Municipal Task Force Against Covid-19 shall take the lead in the enforcement of this Municipal Ordinance.

SECTION 6. PENAL PROVISION. – A fine of Two Thousand Five Hundred Pesos (Php2,500.00) shall be imposed to the violator of this ordinance. Filing of appropriate charges shall be made for subsequent violation.

SECTION 7. SEPARABILITY CLAUSE. If for any reason or reasons, any part or provision of this ordinance shall be declared invalid, the remaining part which are not affected shall continue to be in full force and effect.

SECTION 8. EFFECITIVY. This Ordinance shall take effect upon approval. Posting was done to the 3 conspicuous places of the municipality and to the concerned barangay.
