MUNICIPAL ORDINANCE 2020-010, SERIES OF 2020

AN ORDINANCE DECLARING A PORTION OF FISH LANDING AREA IN BARANGAY POBLACION MUNICIPAL ISOLATION AREA FOR COVID-19 AND ESTABLISHING THE COVID-19 ALEGRIA MUNICIPAL FACILITY AND **PROVIDING ISOLATION** THEREOF AND FOR OTHER PURPOSES

Introduced by: Hon. Ryan T. Abarico

Be it ordained by the Sangguniang Bayan in session assembled that:

SECTION 1. Title -This Ordinance shall be known as an Ordinance declaring a portion of Fish Landing Area within Barangay Poblacion as Municipal Isolation Area for Covid-29 and Establishing the Covid-19 Municipal Isolation Facility and providing funds thereof and for other purposes.

SECTION 2. Declaration of Policy. It is hereby declared as a policy of this Municipality to provide the appropriate isolation area and thereby establish a facility in respond to the Covid-19 Pandemic.

SECTION 3. The Area. There shall be an approximate area of One Hundred Fifty Square Meters (150 sq.m.) out of the Fish landing in area Barangay Poblacion to be delineated as the Municipal Isolation Area for Covid-19.

SECTION 4. ADMINISTRATIVE PROVISION. As an added security from the general public, there shall be constructed a perimeter fence around the isolation facility to keep the unauthorized persons from gaining entry and coming into contact with Covid-19 probable, suspects and/or patients. It shall be unlawful for any person/s to access within the periphery of the Isolation Facility without proper authorization from the Municipal Health Office. Proper warnings and visibly as a forewarning to the public of the health hazards during this Covid-19 Pandemic.

Section 5. FUNDING REQUIREMENT. An amount of Eight Hundred Thousand Pesos (Php800,000.00) from the Bayanihan Grant to Cities and Municipalities (BCGM) under Republic Act 11469, otherwise known as the "Bayanihan to Heal as One Act of 2020" was appropriated under Appropriation Ordinance No. 02, series of 2020 for the construction of the Covid-19 Isolation Facility. Maintenance and Other Operating Expenses thereto shall be taken from the LGU's annual appropriation under the Municipal Health Office. The LGU shall appropriate from any available fund sources as equity for the project. Amount of which shall be determined based on the approved Program of Work and Detailed Engineering Design.

Section 6. OTHER USES. Should it be declared under the Philippine Laws that the Covid-19 is no longer a health threat and Isolation area shall no longer serve its purpose and intent, the area along with the isolation facility shall be converted to other purpose seen fit and applicable by the Local Chief Executive upon authority of the Sangguniang Bayan with its use solely and exclusively in favor of the LGU in the exercise of Local Governance.

SECTION 7. SEPARABILITY CLAUSE. If for any reason or reasons, any section or provision of this ordinance is declared unconstitutional or invalid, the other sections or provisions not affected thereby shall remain in full force and effect;

SECTION 8. REPEALING CLAUSE. All ordinances, rules and regulations, other issuances or parts thereof which are consistent with the ordinance, are hereby repealed or modified accordingly.

SECTON 9. EFFECTIVITY. This Ordinance shall take effect immediately.
