# MUNICIPAL ORDINANCE NO. 2020-015, SERIES OF 2020

AN ORDINANCE SUPPLEMENTING MUNICIPAL ORDINANCE NO. 2020-007 PROVIDING PENALTIES AND FOR OTHER PURPOSES

WHEREAS, cases and transmission of Covid-19 have been rising and the Municipality of Alegria is not spared of its; hence, recently local transmission has been recorded:

WHEREAS, the Provincial Border checkpoints in the Province of Surigao del Norte is off until November 16, 2020 only as provided in the Executive Order No. 20-051 issued by Gov. Francisco T. Matugas and will mean that the LGU shall have its role in the management of Covid-19 within its territorial jurisdiction;

WHEREAS, Republic Act 11332 provided that the state shall endeavor to protect the people from public health threats through efficient and effective disease surveillance among others;

WHEREAS, Municipal Ordinance 2020-007, series of 2020 provided for the provisions to combat against the spread of Corona Virus Diseases (Covid-19) which is now proliferating;

NOW THEREFORE: be it enacted by the Sangguniang Bayan in session assembled, that:

SECTION 1 – **TITLE**. This Ordinance shall be known as the Ordinance supplementing Municipal Ordinance No. 2020-007, series of 2020 particularly Section 3 thereof.

SECTION 2 – **DECLARATION OF POLICY**. It is declared as the policy of the LGU of Alegria to ensure public safety from further spread of COvid-19 by maintaining the standard protocol set by authorities.

SECTION 3 - Regulations. The following regulations shall include the following:

- i. Mandatory wearing of facemasks and face shields. Everybody shall be required to wear facemasks and face shields appropriately when going to public places and to anywhere where people are seen, such as but not limited to:
- a. Public Market;
- b. Grocery stores, sari-sari stores, pharmacy, printing and computer shops and similar business establishments;
- c. Banks, remittance centers, and the like;
- d. Schools, churches and the like;
- e. Government/private offices, Health Centers, BLGU Office and similar institutions;
- f. Transport Terminals, public transport and the like;
- g. Other Places, n.e.c
- ii. Strict Observance to curfew from 8:00 in the evening to 5:00 in the following morning;
- iii. **Computer shops** shall be allowed to open subject to standard health protocols set but authorities for educational purposes only; i.e. for student/teacher research (strictly no gaming allowed) provided only 50% of its capacity is allowed;

## iv. Other Regulations.

 a. Public Market shall have one entrance and one exit; both vendors and customers shall be required compulsory to wear appropriately facemasks and face shields and strictly follow standard protocols set by authorities;

Fines for violators: violator (s) for this provision shall be sanctioned to a fine of Php300.00 for first offense, Php500.00 for second offense; and Php2,500.00 for habitual offenses. However, vendors who commit violation for first offense shall be warned; second offense shall be a one (1) day suspension of business permit and revocation of business permit for third and habitual offenses;

- b. Municipal Tricycle shall be allowed to operate with only three (3) passengers provided that there shall be installed a transparent plastic covering separating the drivers and passengers;
- c. All business establishment, service provides, remittance centers, banks, offices and the like shall be required to install transparent plastic covering.

Tricycles and business establishments not conform with this provisions shall be dealt according to the provisions as cited in Section 9 of the Municipal Ordinance No. 2020-007 and be imposed one a one-day suspension of a business permit.

d. On fish peddling in the barangay. The Barangays shall have the authority to regulate and impose corresponding fees and charges regarding the fish peddling within their respective barangays.

## SECTION 4. ENFORCEMENT AND REWARD SYSTEM.

- i. Anti-Covid Marshall. Every establishment shall be required to deploy/assign one of its employees who shall be then deputized to be an Anti-Covid-19 Marshall by the LGU. Anti-Covid Marshall shall call out and enforce health protocols within their establishment. He or she will then take picture of the violator/s and call the police or authorities for proper apprehension and issuance of a citation ticket.
- ii. **Reward System**. Anyone can call out violator/s of this ordinance, by taking a picture of the violation and present to the proper authorities for issuance of a citation ticket. The informant will then get the 50% of the fines as reward.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect upon its approval.
