**RESOLUTION NO. 2021-018, SERIES OF 2021**

**A RESOLUTION EARNESTLY REQUESTING THE  
PROVINCIAL GOVERNMENT OF SURIGAO DEL  
NORTE THRU HONORABLE GOVERNOR FRANCISCO  
T. MATUGAS TO EXTEND FINANCIAL ASSISTANCE  
AMOUNTING TO Php5,000,000.00 TO THE  
MUNICIPALITY OF ALEGRIA FOR ITS PROJECTS,  
PROGRAMS AND ACTIVITIES RELATED TO COVID-19**

**WHEREAS**, the Office of the Municipal Mayor sent a letter to the Sangguniang Bayan requesting to pass a resolution to ask Provincial Government thru the Honorable Governor Francisco T. Matugas for financial assistance to fund for the various Covid-19 related PPAs;

**WHEREAS**, the national government mandated each LGUs to implement a comprehensive and responsive disaster risk reduction program based on the principle of good and governance;

**WHEREAS**, the government declared as one of its policy to reduce the adverse impact of Covid-19 on the socio-economic well-being of the Filipinos through provision of assistance and other form of relief;

**WHEREAS**, the Municipality of Alegria sets out plans, programs, activities to curb the transmission of Covid-19 in the municipality of Alegria as part of its initiative;

**WHEREAS**, currently Alegria is one of the LGUs being affected by the adverse effect of Covid-19 after many of its constituents returned home after being stranded in the major cities; jobless and detached who need the necessary assistance from the government;

**WHEREAS**, adding to this Covid-19 burden is the recent crisis attributed by TS Auring which had caused distress to the LGU after several people were displaced from the severe flooding including the newly planted rice crops and other agriculture endeavors where people demanded immediate assistance;

**WHEREAS**, the LGU's disaster fund is almost consumed due to the increased cases of Covid-19 and other related calamities and with its meager budget, it can no longer accommodate to fund other related activities;

**WHEREAS**, this LGU is earnestly calling the Provincial Government of Surigao del Norte to extend help by extending a financial assistance to the LGU of Alegria in its effort to recover from the adverse effect of Covid-19;

**WHEREFORE**, considering the above premises, it was:

**RESOLVED AS IT IS HEREBY RESOLVED** to request the Provincial Government of Surigao del Norte thru Honorable Governor Francisco T. Matugas to extend financial assistance to the LGU Alegria amounting to Php5,000,000.00 to be used for its Covid-19 related Projects, Programs and Activities;

**FURTHER RESOLVED** that this resolution be forwarded to the agencies concerned for appropriate information and most favorable action.
