RESOLUTION NO. 2021-019, SERIES OF 2021

A RESOLUTION ENDORSING TO THE MUNICIPAL DEVELOPMENT FUND OFFICE (MDFO) THE MDRRMC RESOLUTION NO. 01, SERIES OF 2021, ENTITLED: "RESOLUTION REQUESTING FOR THE MORATORIUM PAYMENT OF LOAN AMORTIZATION OF HEAVY EQUIPMENT CHARGED AGAINST LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF) FOR CY 2021 IN THE MUNICIPALITY OF ALEGRIA, SURIGAO DEL NORTE"

WHEREAS, the Local Disaster Risk Reduction and Management Council (LDRRMC) is mandated the role to act as an advisory council to the LGU on matters relating to disaster planning, management and risk reduction;

WHEREAS, the national government mandated each LGUs to implement a comprehensive and responsive disaster risk reduction program based on the principle of good and governance;

WHEREAS, the government declared as one of its policy to reduce the adverse impact of Covid-19 on the socio-economic well-being of the Filipinos through provision of assistance and other form of relief;

WHEREAS, the Municipality of Alegria sets out plans, programs, activities to curb and/or contain the transmission of Covid-19 in the municipality of Alegria as part of its initiative but there is a need of an additional fund with this unexpected eventuality brought by Covid-19;

WHEREAS, the LDRRMC during its meeting recommended to seek MDFO's approval for a moratorium of LGUs loan amortization for 2021 to fund the various COvid-19 response PPA's and other disaster that beset the municipality;

WHEREFORE, considering the above premises, it was:

RESOLVED AS IT IS HEREBY RESOLVED to endorse to the Municipal Development Fund Office (MDFO) the MDRRMC Resolution No. 01, series of 2021, entitled: "Resolution requesting for the moratorium payment of Loan Amortization of Heavy Equipment charged against the Local Disaster Risk Reduction and Management Fund (LDRRMF) for CY 2021 in the Municipality of Alegria, Surigao del Norte"
