**A RESOLUTION ENDORSING TO THE DEPARTMENT
OF SOCIAL WELFARE AND DEVELOPMENT (DWS),
THE MDRRMC RESOLUTION NO. 03-2021, SERIES OF
2021, ENTITLED: " RESOLUTION REQUESTING THE
DSWD TO ALLOCATE THE 20% OF THE
PHP9,606,600.00 KALAHI-CIDSS: ADDITIONAL
FINANCING- COMMUNITY-BASED RESPONSE TO
COVID-19 (KC-AF-CBRC) GRANT FUND FOR THE
MUNICIPALITY OF ALEGRIA, SURIGAO DEL NORTE
TO BE UTILIZED FOR VACCINE PROCUREMENT"**

WHEREAS, the Local Disaster Risk Reduction and
Management Council (LDRRMC) is mandated the role to act as
an advisory council to the LGU on matters relating to disaster
planning, management and risk reduction;

WHEREAS, the national government mandated each LGUs to
implement a comprehensive and responsive disaster risk
reduction program based on the principle of good and
governance;

WHEREAS, the government declared as one of its policy to
reduce the adverse impact of Covid-19 on the socio-economic
well-being of the Filipinos through provision of assistance and
other form of relief;

WHEREAS, Alegria is one of the LGUs to receive a grant from DSWD Caraga for the KALAHY-CIDSS: additional financing-Community-Based Response to Covid-19 (KC-AF-CBRC) amounting to Php9,606,600 intended for the prevention and mitigation of the current health crisis;

WHEREAS, one of the significant issues that the LGU considered to be a challenge is the procurement of vaccine for Covid-19 but the LGU fund particularly the LDRRMF is not sufficient; hence this resolution;

WHEREFORE, considering the above premises, it was:

RESOLVED AS IT IS HEREBY RESOLVED to endorse to the Department of Social Welfare and Development (DSWD), the MDRRMC Resolution No. 03-2021, series of 2021 entitled: "Resolution Requesting the DSWD to allocate the 20% of the Php9,606,600.00 KALAHY-CIDSS: Additional Financing -Community-Based Response to Covid-19 (KC-AF-CBRC) grant fund for the Municipality of Alegria, Surigao del Norte to be utilized for vaccine procurement"
