RESOLUTION NO. 2021-025, SERIES OF 2021

RESOLUTION DECLARING AS VALID BARANGAY ORDINANCE NO. 01, SERIES OF 2021 " AN ORDINANCE REQUIRING ALL QUALIFIED RESIDENTS IN BARANGAY BUDLINGIN, ALEGRIA, SURIGAO DEL NORTE AGES 15 AND ABOVE YEARS OLD TO SECURE BARANGAY ID FOR EASY ACCESS OF THEIR TRANSACTION IN THE BARANGAY AND CHARGING FEES THEREOF"

WHEREAS, Barangay Ordinance No. 1, series of 2021 required the issuance of Resident Identification Card to all qualified constituents aging 15 years old and above in the Barangay purposely to identify individuals within its territorial jurisdiction and give them ease of transaction in the barangay;

WHEREAS, this Barangay ID System is timely for the Barangay to monitor the arrival and departing people in the barangay especially during this time of pandemic;

WHEREAS, barangay identification cards shall also serve as a valid proof of identification of all barangay residents in line with the mandates of the Republic Act 11055, otherwise known as the Philippine ID system Act of 2018

NOW THEREFORE: be it resolved as it is hereby resolved to declare as valid the Barangay Ordinance entitled " An Ordinance requiring all qualified in Barangay Budlingin, Alegria, Surigao del Norte ages 15 and above years old to secure Barangay ID for easy access of their transaction in the barangay and charging fees thereof."
